Pool Information

8:00am - 11:00am	Adult Swim	Adults only - no one under 18 permitted

NOTE: The pool will be closed when the temperature is below 70 degrees OR during inclement weather (thunder, lightning, storm warning and heavy rains) in the area. The pool will re-open and Attendant service will resume at the Pool Committee's discretion.

Admittance to the Pool

- Each homeowner will receive a resident log form at the pool or online each pool season. Please complete the form and submit it to an attendant upon or before visiting the pool.
- The pool is open to all residents and their guests. All children under 16 must be accompanied by parent or guardian during unattended hours. A guardian is 16 years old or older and is specified on a **submitted & signed** Resident's Log Form
- Owners must sign themselves and their guests in and out of the pool using first and last names each time they use the pool.

Guests of a Resident

- Residents include homeowners and their children **of all ages including adult children**. All others are considered guests. Spouses of children, and grandchildren are also considered guests.
- Each household or lot owner is allowed a total of **6** guests per visit. If you would like to bring more than 6 guests at one visit, please contact a member of the pool committee in advance.
- Only residents living in Oak Creek Subdivision can bring quests.
- The resident shall be present at the pool with any of their guest(s) for the entire duration their guest(s) are present at the pool and are responsible for their guest(s).

Pool Use

- **Use of the facility by residents and guests is at their own risk.** The pool attendants, pool committee and the board of directors cannot be held responsible for any incidences or accidents that happen in or around the pool, or any lost or stolen property.
- **Parents or guardians are responsible for supervising their children** with respect to all of the pool rules at all times while at the pool.
- **No Lifeguards are on duty.** Attendants are present to oversee the pool area, monitor compliance of the pool rules and assist with operational needs.

- Disrespectful, rude, crude, or otherwise inappropriate language and sexual innuendo or unruly behavior by a resident or guest of a resident will NOT BE TOLERATED.
- **NO SMOKING OR VAPING** or hazardous items permitted.
- Pets are NOT allowed within the pool area or in the clubhouse.
- Food & drinks are admissible in the Designated Area Only. **(No glass)** No gum allowed.
- Residents are responsible for picking up their own litter and placing it in the proper receptacles.

Swimming

- **Emergency Procedures:** Three short quick blasts from the attendant's whistle signals an emergency in the water. Upon hearing this signal, all persons in the pool are to immediately get out of the water. There may be emergency drills periodically.
- No pushing, shoving or running around the pool.
- Only 1 person on the diving board at a time. **No backwards diving allowed.**
- Diving is allowed in marked areas only.
- Admission to the pool shall be refused to:
 - a. All persons having any contagious disease or infectious conditions.
 - b. All persons with excessive sunburn, unhealed abrasions, and bandages.
 - c. All persons under the influence of alcohol, exhibiting erratic or obnoxious behavior.
- All persons are encouraged to take a shower before entering the pool area.
- Flotation devices will be allowed at the discretion of the attendant or during family swim times with low attendance. Large flotation devices/toys pose visual obstruction dangers.
- No Spitting, spouting water, blowing the nose or introducing contaminants into the pool.
- All children who are not toilet-trained are **required to wear swim diapers.**

Disciplinary Action

Residents and guests that do not comply with the pool safety rules will have the following consequences:

1st infraction	Verbal warning from the Attendant or Pool Committee
2nd infraction	Verbal warning and a written warning from the Pool Committee
3rd infraction	With Board approval, letter from The Building Group with a \$50 fine

Pool may be rented by Oak Creek homeowners for special gatherings, parties or events. The State Capacity Limit of the pool is 61, thus limiting the size of the outside gathering.

There will be a **\$100.00 pool use** non-refundable charge payable when a reservation is made. There will also be a **\$250.00 damage** deposit which will be returned after a committee/coordinator final walk-through.

POOL TOYS & OTHER ITEMS PICKED UP & PUT AWAY (that night)

BATHROOMS TIDIED (toilets flushed, garbage removed, etc.)

All gatherings must be supervised by one of **OUR POOL ATTENDANTS** due to their familiarity with the Oak Creek pool rules, the pool equipment and emergency procedures. The standard cost for the attendant shall be a minimum of \$15.00 per hour.

One Attendant is required for every 25 guests.

Hours of private pool use shall be:

6:00 p.m. to 10:00 p.m. Sunday through Thursday

7:00 p.m. to 11:00 Friday and Saturday.

The hours will be strictly enforced; no guests of a “pool party” will be admitted prior to the starting time. Residents of Oak Creek are allowed to use the Pool facilities until 8pm.

All Pool Safety Rules set forth by the Oak Creek Homeowners Association shall apply whenever the pool is used for a private party, event or function. Please refer to Oak Creek website for pool information. Let's take pride in our facility and be respectful. It is an extension of our home.

THE POOL AREA IS NOT OPEN TO A CLUBHOUSE GATHERING, EVENT OR PARTY IF THE POOL HAS NOT BEEN SPECIFICALLY RENTED. As well, the clubhouse is not open to a POOL gathering, party or event if it has not been specifically rented.
